

INTRODUCTION

"Hermione" - La collection la plus importante de la période semi-moderne jamais offerte en vente aux enchères

Quinze ans après la vente de la collection "LaFayette"– la vente de France ayant réalisé le plus grand total vendu, plus de 5 millions d'euros en 120 lots, et détenant toujours le record absolu pour un timbre de France avec 925,000 euros pour le bloc de 4 du 1f vermillon de 1849 avec tête bêche – Spink a l'honneur et le plaisir d'annoncer la vente aux enchères dans ses locaux à Londres, les 21 et 22 Novembre 2018, de la Collection "Hermione". Cette collection est tout simplement aux semi-modernes de France, ce qu'était Lafayette aux classiques de France: la référence ultime.

Cette première vente consistant en plus de 1250 lots, attirera sans aucun doute l'intérêt de tous les philatélistes au monde, intéressés par les superbes émissions de France entre 1900 et 1950. Au-delà des semi-modernes, la collection couvre aussi la partie classique avec également de grandes pièces comme de superbe premier jour du 1er Janvier 1849, le 1fr vermillon sur lettre, la première date connue de l'utilisation du 5f Empire sur lettre, peut-être le plus beau type sage bleu de Prusse connu.... Mais son exceptionnelle profondeur réside dans la partie semi-moderne car le collectionneur discret qui a constitué cet ensemble unique, a pendant près de soixante-dix ans cherché les plus belles variétés existantes. La vente a été conçue pour offrir des lots à tous types de collectionneurs, de la spectaculaire variété sur type Blanc ou Semeuse avec des prix de départ à 50 euros, aux grandes raretés de la philatélie française à 100,000 euros et davantage. Afin d'encourager les acheteurs français et européens, la vente se fera en euros, bien qu'elle ait lieu à Londres. La vente contiendra aussi des mini collections sur chaque timbre. Ce sera pour de nombreux philatélistes l'opportunité de commencer de manière sérieuse et rapide une nouvelle collection en se portant acquéreur d'une ou plusieurs de ces collections d'un niveau de rareté et de qualité tout à fait exceptionnel.

L'exposition des lots aura lieu lors du salon d'Automne de la Porte de Champerret du 8 au 11 Novembre 2018, de 10h à 18h à l'Hôtel Ampère, 102 avenue de Villiers, 75017 Paris, à quelques minutes à pied de l'Espace Champerret. Tous les détails sont disponibles dans ce catalogue, sur notre site internet ou sur notre stand habituel (A6) au salon d'Automne. La vente est divisée en six catalogues regroupant différentes émissions, afin que chaque collectionneur puisse garder un memento de cette vente exceptionnelle. A n'en point douter ces catalogues, avec les prix réalisés, deviendront une référence pour tous les collectionneurs de France. Comme Lafayette en son temps, Hermione devrait donner un coup de projecteur sur le marché philatélique français, permettant de mettre en avant dans une vente ouverte au public, les séries les plus collectionnées et les plus désirées de la philatélie française.

Il y aura sans doute un "avant" Hermione, et un "après" Hermione.

Si ils ne souhaitent pas se déplacer, les collectionneurs français habitués aux ventes sur offres, pourront évidemment envoyer leurs offres par courrier ou fax, comme s'il s'agissait d'une VSO classique, laisser leurs offres sur notre site, ou enchérir sur SpinkLive sur internet ou au téléphone. Le plaisir que nous connaissons tous à la publication des résultats d'une VSO est encore renforcé lors d'une vente aux enchères que tous peuvent suivre, sur place ou sur internet avec le son et l'image du direct.

INTRODUCTION

"Hermione" The Most Important Collection of Semi-Modern France Ever Offered at Auction

Fifteen years after the sale of the "Lafayette" collection in 2003 – the most valuable collection of classic France ever to hit the market, including the highest price paid at auction (€925,000) for a philatelic item of France: the 1849 1fr. vermilion block of four containing a tête-bêche – Spink is pleased to present this series of catalogues for the "Hermione" Collection, an extraordinary assembly dedicated to the classic and semi-modern periods of French philately. The sale will also include balances and collections of single stamps or issues, being highly significant and difficult to find for their comprehensiveness.

The "Hermione" sale is being promoted in France, during the annual Salon Philatelique d'Automne in Paris at the Space Champerret from 8th to 11th November, where Spink will be present at Stand A6. The viewing of the lots during the Salon will be at the Hotel Ampere (a few minutes away on foot from the Espace Champerret). There you will be able to view these rarities in peace and at your leisure. And, of course, there will be an opportunity for viewing at our premises in central London, where the sale will take place.

This extraordinary sale will undoubtedly leave a legacy for future generations of collectors, denoting varieties recorded or unrecorded, and prices for reference. We kindly invite you to participate in this event, which will represent a unique opportunity and will be another landmark in the history of French philately.

The Hermione auction will be a pivotal moment in French philately.







La toute jeune troisième république proclamée le 20 mai 1875, Annonce dès le 9 août 1875 l'ouverture d'un concours visant à la créations d'un nouveau type de timbre-poste. Le 14 septembre, le Journal Officiel publie le nom de la maquette retenue « le commerce et la paix » de Jules Auguste SAGE.

La gravure est confiée à Louis Eugène Mouchon. Le début de l'aventure de cette série de timbre est incroyable. Le premier poinçon se fend lors de la trempe de celui-ci, et le graveur doit recommencer son travail. De cet incident vont naitre les deux grands types « N sous U » et « N sous B ».

Le 15 centimes gris est émis vers le 15 juin 1876.

Dans un premier temps les timbres-poste présentant une valeur faciale inférieure à 15c sont toutes imprimées en vert (5 valeurs), en tout cette première émission est composée de 13 valeurs, couvrant l'intégralité des besoins pour les tarifs postaux en vigueur.

A partir de 1877, les petites valeurs ne sont plus imprimées dans la même couleur. De ce changement initié par la décision du 30 novembre 1876, deux timbres exceptionnels vont en découler. Le premier le timbre non-émis à 20 centimes bleu, et plus tard le 1c bleu de Prusse, deux véritables « raretés » de la philatélie française.

Avec la suppression de la distinction des tarifs des lettres locales, et les modifications imposées par le respect des traités de l'U.P.U. les timbres-poste changent de couleurs en s'adaptent aux exigences règlementaires et/ou tarifaires.

Les travaux de nombreux philatélistes ont alimenté les découvertes pendant de nombreuses années, et nombres de valeurs se décline avec des sous-types et/ou des états.

Changement de lieu d'impression en 1880, petites retouches sur les poinçons, types différents, types se tenant, papiers différents avec notamment le papier quadrillé du 15 centimes bleu, modification des inscriptions de service et apparition des millésimes en 1891... font de cette série de timbres-poste qui ont accompagné la vie des français durant pratiquement 25 ans, une série majeure de la philatélie française.

The 1 cent Prussian blue is one of the most prestigious stamps of France. This stamp is part of the second so-called 1877 issue printed by the Bank of France. In the "Type Sage" first issue all stamps were printed in the same colour: green. Therefore, at the end of 1876 it was decided to differentiate the colours of these stamps depending on their denominations. The 1c becomes black on bluish paper. The bluish colour is obtained by a hue affixed in the background of security. In 1880 the colour of this background becomes very pronounced and results in a specific nuance which philatelists named "Prussian blue". In the example presented here, the margin of the sheet clearly shows the use of a control background to which a cross "croix de repère" is added with the purpose of having a visual reference for the positioning of the tool to perforate the stamps.

Catalogue and web illustrations are for guidance only, and should not be relied on either to determine the tone or colour of any item. No lot shall be rejected on the grounds of inaccurate reproduction. No lot illustrated in the catalogue and national be rejected on the grounds of cancellation, centring, margins, perforation or other characteristics apparent from the illustration.  - 3.4.1 If you wish to obtain an expert opinion or Certificate of Authenticity on any Lot (other than a mixed Lot or Lot containing undescribed stamps) you must notify us in writing not less than forty-eight hours before the time fixed for the commencement of the first session of the sale. If accepted by us, such request shall have the same effect as notice of an intention to question the genuineness or description of the Lot for the purposes of clause 5.13 (Refund in the case of Forgery) of these Terms and Conditions and the provisions of clause 5.13 (Refund in the case of Forgery) shall apply accordingly.
 - 3.4.2 Notice of a request for an expert opinion or Certificate of Authenticity must give the reason why such opinion is required and specify the identity of your proposed expert which will be subject to agreement by us. 4.11 The Auctioneer's Discretion

The auctioneer has the right at his absolute discretion to refuse any bid to advance the bidding in such manner as he may decide to withdraw or divide any Lot, to combine any two or more Lots and, in the case of error or dispute, to put an item up for bidding again.

4.12 Successful Bid

Subject to the auctioneer's discretion, the striking of his hammer marks the acceptance of the highest bid, provided always that such bid is higher than the Reserve (where applicable), and the conclusion of a contract for sale between you and the Seller.

4.13 After Sale Arrangements

If you enter into any private sale agreements for any Lot with the Seller within 60 days of the auction, we, as exclusive agents of the Seller reserve the right to charge you the applicable Buyer's Premium in accordance with these Terms and Conditions, and the Seller a commission in accordance with the terms of the Seller's agreement.

4.14 Return of Lot

4.14.1 Once your bid has been accepted for a Lot then you are liable to pay for that Lot in accordance with these Terms and Conditions. If there are any problems with a Lot then you must notify us within 7 days of receipt of the Lot, specifying the nature of the problem. We may then request that the Lot is returned to us for inspection. Save as set out in clause 5.13, the cancellation of the sale of any Lot and the refund of the corresponding purchase price is entirely at our sole discretion. We will not normally exercise that discretion if the Lot is not received by us in the same condition that it was in at the auction date.

4.14.2 No lot may be returned on account of condition if the condition was stated by a third party grading company (including, but not limited to PCGS, NGC, ANACS, ICG, PMG, WBG).

5 AFTER THE AUCTION

5.1 Buyer's Premium and other charges

In addition to the Hammer Price, you must pay us the Buyer's Premium at a rate of 20% of the final Hammer price of each lot, a fee of 3% on the hammer price total for using the-saleroom.com and a fee for paying by card.

5.2 Value Added Tax

- 5.3.3 To apply for a refund of any VAT paid, the proof of export certificate must be sent to our Shipping Department clearly marked 'VAT Refund' within 3 months of the date of sale. No payment will be made where the total amount of VAT refundable is less than £50 and Spink will charge £50 for each refund processed.

VAT Refunds - Buyers from within the EU

- 5.3.4 VAT refunds are available on the Hammer Price and Buyer's Premium of Daggered (†) and Investment Gold (g) Lots. You must certify that you are registered for VAT in another EU country and that the Lot is to be removed from the United Kingdom within 3 months of the date of sale.
- 5.3.5 Where an EU buyer purchases a Lot on which import VAT has been charged, no refund of VAT is available from us. It may be possible to apply directly for a refund on form VAT 65 to HM Revenue & Customs Overeseas Repayment Section, Londonderry.

VAT Refunds - Buyers from outside the EU

- 5.3.6 Where a Lot is included within the Auctioneers' Margin Scheme and evidence of export from the EU is produced within 3 months of the date of sale, the VAT on Buyer's Premium may be refunded.
- 5.3.7 Where the Lot is marked as a Daggered (†) Lot the VAT charged on the Hammer Price may be refunded where evidence of export from the EU is produced within 3 months of the date of sale. A refund of VAT charged on the Buyer's Premium can also be made on receipt of proof of business as a collectibles dealer.
- 5.3.8 Where the Lot is marked as an Omega (Ω) Lot or an Import VAT (x) Lot and evidence of export from the EU is produced within 3 months of the date of sale, the VAT charged on both the Hammer Price and Buyer's Premium may be refunded. Where required, we can advise you on how to export such Lots as a specific form of export evidence is required. Where we advise you on the export of the Lots, please be aware that the ultimate responsibility in respect of obtaining a valid proof of export certificate will not be responsible for your failure to obtain such certificate.
- 5.3.9 Lot marked as Investment Gold (g) is exempt from VAT on Hammer price. A refund of VAT charged on the Buyer's Premium can be made on receipt of proof of business as a collectibles dealer and where evidence of export from the EU is produced within 3 months of the date of sale.

5.4 Payment

- Fayment 5.4.1 You must provide us with your full name and permanent address and, if so requested, details of the bank from which any payments to us will be made. You must pay the full amount due (comprising the Hammer Price, the Buyer's Premium and any applicable VAT) within seven days after the date of the sale. This applies even if you wish to export the Lot and an export licence is (or may be) required.
