



INTRODUCTION

"Hermione" - La collection la plus importante de la période semi-moderne jamais offerte en vente aux enchères

Quinze ans après la vente de la collection "LaFayette" – la vente de France ayant réalisé le plus grand total vendu, plus de 5 millions d'euros en 120 lots, et détenant toujours le record absolu pour un timbre de France avec 925,000 euros pour le bloc de 4 du 1f vermillon de 1849 avec tête bêche – Spink a l'honneur et le plaisir d'annoncer la vente aux enchères dans ses locaux à Londres, les 21 et 22 Novembre 2018, de la Collection "Hermione". Cette collection est tout simplement aux semi-modernes de France, ce qu'était Lafayette aux classiques de France: la référence ultime.

Cette première vente consistant en plus de 1250 lots, attirera sans aucun doute l'intérêt de tous les philatélistes au monde, intéressés par les superbes émissions de France entre 1900 et 1950. Au-delà des semi-modernes, la collection couvre aussi la partie classique avec également de grandes pièces comme de superbe premier jour du 1er Janvier 1849, le 1fr vermillon sur lettre, la première date connue de l'utilisation du 5f Empire sur lettre, peut-être le plus beau type sage bleu de Prusse connu.... Mais son exceptionnelle profondeur réside dans la partie semi-moderne car le collectionneur discret qui a constitué cet ensemble unique, a pendant près de soixante-dix ans cherché les plus belles variétés existantes. La vente a été conçue pour offrir des lots à tous types de collectionneurs, de la spectaculaire variété sur type Blanc ou Semeuse avec des prix de départ à 50 euros, aux grandes raretés de la philatélie française à 100,000 euros et davantage. Afin d'encourager les acheteurs français et européens, la vente se fera en euros, bien qu'elle ait lieu à Londres. La vente contiendra aussi des mini collections sur chaque timbre. Ce sera pour de nombreux philatélistes l'opportunité de commencer de manière sérieuse et rapide une nouvelle collection en se portant acquéreur d'une ou plusieurs de ces collections d'un niveau de rareté et de qualité tout à fait exceptionnel.

L'exposition des lots aura lieu lors du salon d'Automne de la Porte de Champerret du 8 au 11 Novembre 2018, de 10h à 18h à l'Hôtel Ampère, 102 avenue de Villiers, 75017 Paris, à quelques minutes à pied de l'Espace Champerret. Tous les détails sont disponibles dans ce catalogue, sur notre site internet ou sur notre stand habituel (A6) au salon d'Automne. La vente est divisée en six catalogues regroupant différentes émissions, afin que chaque collectionneur puisse garder un memento de cette vente exceptionnelle. À n'en point douter ces catalogues, avec les prix réalisés, deviendront une référence pour tous les collectionneurs de France. Comme Lafayette en son temps, Hermione devrait donner un coup de projecteur sur le marché philatélique français, permettant de mettre en avant dans une vente ouverte au public, les séries les plus collectionnées et les plus désirées de la philatélie française.

Il y aura sans doute un "avant" Hermione, et un "après" Hermione.

Si ils ne souhaitent pas se déplacer, les collectionneurs français habitués aux ventes sur offres, pourront évidemment envoyer leurs offres par courrier ou fax, comme s'il s'agissait d'une VSO classique, laisser leurs offres sur notre site, ou enchérir sur SpinkLive sur internet ou au téléphone. Le plaisir que nous connaissons tous à la publication des résultats d'une VSO est encore renforcé lors d'une vente aux enchères que tous peuvent suivre, sur place ou sur internet avec le son et l'image du direct.

INTRODUCTION

The Most Important Collection of Semi-Modern France Ever Offered at Auction

Fifteen years after the sale of the "Lafayette" collection in 2003 – the most valuable collection of classic France ever to hit the market, including the highest price paid at auction (€925,000) for a philatelic item of France: the 1849 1fr. vermilion block of four containing a tête-bêche – Spink is pleased to present this series of catalogues for the "Hermione" Collection, an extraordinary assembly dedicated to the classic and semi-modern periods of French philately. The exceptional nature of this collection lies in this later period, representing what must be considered as the most important assembly of semi-modern France ever offered at auction, and which is of equal importance as "Lafayette" for semi-modern France.

The length of this introduction constrains us from mentioning its many highlights, however, we invite you to peruse these catalogues for a jaw dropping experience. The sale will also include balances and collections of single stamps or issues, being highly significant and difficult to find for their comprehensiveness.

The "Hermione" sale is being promoted in France, during the annual Salon Philatelique d'Automne in Paris at the Space Champerret from 8th to 11th November, where Spink will be present at Stand A6. The viewing of the lots during the Salon will be at the Hotel Ampere (a few minutes away on foot from the Espace Champerret). There you will be able to view these rarities in peace and at your leisure. And, of course, there will be an opportunity for viewing at our premises in central London, where the sale will take place.

This extraordinary sale will undoubtedly leave a legacy for future generations of collectors, denoting varieties recorded or unrecorded, and prices for reference. We kindly invite you to participate in this event, which will represent a unique opportunity and will be another landmark in the history of French philately.

The Hermione auction will be a pivotal moment in French philately.



Buyers are reminded that any lot(s) purchased "on extension" are subject to payment in accordance with our normal Terms & Conditions of Business. Settlement of any lots on extension should be made at the time of invoice payment. Overdue accounts are subject to interest charges.

Extensions requested on account of condition will not be accepted for expert opinions. Any Lot described as having faults or defects may not be returned should a certificate cite other faults or defects not included in the catalogue description.

Should Spink accept a request for an extension under the foregoing provisions of this paragraph, the fact may be stated by the Auctioneer from the rostrum prior to the sale of the lot.

1928 "Ile de France" Issue and Mail

Surcharge Ile de France

Le gain de temps dans l'acheminement du courrier a toujours été une préoccupation. Les relations transatlantiques n'échappent pas à la règle. Si la première expérience de ce type a été réalisée le 15 octobre 1913, la plus remarquable et la plus extraordinaire aventure philatélique ayant laissée une trace sur les courriers est sans nul doute celle des timbres-poste surchargés dit « Ile de France ».

Le paquebot « Ile de France » est livré le 29 Mai 1927 et fait son voyage inaugural du Havre vers New York le 22 Juin 1927. Il est exploité par la Compagnie Générale Transatlantique

L'idée est de lancer à partir du bord de L'Île de France, un hydravion lorsque le bateau approche des cotes de destination, afin de gagner quelques précieuses heures.

Bien sûr cette nouvelle possibilité devait être rétribuée, et l'Administration des P.T.T. publia le 4 août 1928 une note dans laquelle sont précisées les surtaxes à apposer sur les courriers. L'affranchissement de cette surtaxe est obligatoirement en timbres-poste français.

Ainsi pour les lettres, carte postale et paquets non clos jusqu'à 10 grammes l'expéditeur devait s'acquitter d'une surtaxe de 10 francs, puis au-delà de 10 grammes 5 francs par fractions de 5 grammes.

Pour les autres objets, une surtaxe de 5 francs par 50 grammes ou fraction de 50 grammes était applicable pour les papiers d'affaires, journaux, imprimés et échantillons.

Le 16 août 1928 à son arrivée à New York, le contrôleur des postes à bord de l'Le de France, Jules Cohen se rendit au consulat de France. Il y rencontra Maxime Mongendre, Consul de France, à qui il fit part « (...) de l'utilisation en totalité, au cours de la traversée du Havre à New-York, des timbres de frs10-».

Jules Cohen ayant précisé qu'il lui restait des timbres-poste à 0.90 frs et 1.50 frs, autorisa que ces timbres soient surchargés frs. 10. C'est l'imprimerie French Printing and Publishing Cie de Monsieur Camille Cabella située au 149 west 24th Street à Nez York. qui réalisa la surcharge sur 1 000 timbres à 1.50 frs et 3 000 à 0.90 frs, le jour même.

Est précisé dans le procès-verbal, que ces timbres-poste ne peuvent être utilisés uniquement qu'au cours de la traversée du 18 au 24 août 1928, et que les vignettes non utilisées devront être présentées à l'agent des postes avant l'arrivée du paquebot au Havre.

Les timbres surchargés sont ceux en usage à cette époque à savoir le 1,50 frs au type Pasteur, et le 0.90 frs au type Berthelot. Ces timbres sont surchargés 10 Fr. = en noir, la surcharge est imprimée en typographie à plat, par panneau de 50 exemplaires.

Au niveau des galvanos de surcharge, il est à noter que l'avant dernière rangée présente un écartement entre la base des chiffres et les barres de 8 mm au lieu de 6 mm pour les autres timbres, dénommé « chiffres espacés ».

Un fragment de feuille de 50 exemplaires du 0.90 frs fut surchargé à l'envers.

L'intégralité des timbres 10 frs sur le 1,50frs Pasteur furent vendus, et 2636 timbres sur le 0.90 frs Berthelot furent vendus.

An Extraordinary "Berthelot" Pair Exhibiting Inverted Normal and Spaced Surcharges

Only 50 stamps with this variety were printed, of which only five have the wide spacing. An absolutely extraordinary piece featuring the two varieties occurring in this stamp - only five examples are known with the inverted spaced surcharge, in this instance it is further enhanced by being part of a se-tenant pair; not only one of the greatest gems of post-classic France, but also one of the greatest rarities of worldwide airmails. Spink Maury 3var; the quotations are €20,000 for the inverted surcharge and €75,000 for the inverted spaced surcharge, not being registered as a se-tenant pair yet

Saving time in mail delivery has always been a concern, and the transatlantic postal relations are no exception to the rule. One of the most remarkable philatelic adventures of the airmails is undoubtedly that of the surcharged stamps known as "Ile de France". The idea was that of launching a seaplane from the edge of the "Ile de France" ocean liner, when the ship approached its transatlantic destination, in order to gain various hours which would mean one day in the mail delivery. The PTT Administration published, on 4 August 1828, a note in which the surcharges on the stamps to be affixed to letters carried by this service were specified. Thus, for letters, postcards and unenclosed parcels up to 10 grams, the sender had to pay a surcharge of 10 francs, and then 5 francs in fractions of 5 grams for mail weighing more than 10 grams. On 16 August 1928, the postman on the "Ile de France", Jules Cohen, after his arrival to New York, went to the consulate of France to meet Maxime Mongendre, French Consul, to whom he communicated "the complete usage, during the journey from Le Havre to New York, of all 10 francs stamps". Jules Cohen, having specified that he still had postage stamps of 90 centimes and 1.50 francs, was authorized by the consul to surcharge these stamps with 10 francs each. The French Printing and Publishing Co. was then the printer which applied the surcharge on 1,000 stamps of 1.50 francs and 3,000 stamps of 90c., on the same day. The surcharge was applied typographically on panes of 50 stamps. It should be noted that the surcharge in the penultimate row presented a wider spacing between the base of the figures and the bars, this being 8 mm instead of the 6 mm which were the norm for the other stamps. A block of 50 examples of the 10fr. on 90c. "Berthelot" was applied inverted, so there are only 5 possibilities to find this extraordinary pair featuring the inverted surcharge and including one with wide spacing.





La première exposition internationale de Poste Aérienne est organisée par l'Aéro-Club de France, au pavillon Marsan du 6 au 20 novembre 1930.

Pour la promotion de cet évènement, une demande d'émission d'un timbre-poste est adressée à Monsieur Germain Martin alors Ministre des P.T.T. Si celui-ci n'accorde pas l'émission d'un timbre, le Ministre propose d'imprimer le timbre de poste aérienne ayant cours en bleu au lieu de rouge. Le tirage de ce timbre étant de 60 000 exemplaires.

Entre l'accord initial et la manifestation, 4 ministres se succédent en 8 mois. Finalement, Mallarmé alors Ministre décrète que le 1fr50 de Poste Aérienne serait imprimé en outremer et que la mise en vente aurait lieu dans un premier temps sur la manifestation pendant toute la durée de l'exposition.

Ce timbre outremer est imprimé les 12, 16,17 et 24 septembre 1930 dans des teintes plus ou moins vives.

5 jours après l'inauguration, le président de la république Paul Doumergue rend visite officiellement à l'exposition accompagné par son Ministre des Postes. Suite à cette visite et aux éloges reçues, le commissaire général de l'exposition propose au Ministre de perforer les timbres-poste EIPA 30 (pour Exposition Internationale Poste Aérienne 1930). Le Ministre accepte cette proposition.

Rappelons que depuis Le 15 novembre 1876, le Ministre des finances autorise le public à marquer les timbres-poste dont il fait usage de signes distinctifs obtenus au moyen d'emporte-pièce. Ces marques ne devaient pas dépasser le tiers de la superficie des timbre et devaient être apposées à leur partie supérieure et ne devaient jamais altérer le chiffre de la valeur. Cette décision fut publiée dans le Bulletin mensuel des Postes n°92 de novembre 1876

Pour accélérer la perforation des timbres-poste, les feuilles de 25 exemplaires furent pliées en accordéon dans le sens de la largeur, découpées, puis ces bandes furent à nouveau repliées sur elles même en accordéon, ainsi un paquet de cinq timbres passait dans la machine.

Ces timbres sur documents sont beaucoup plus rares que les timbres neufs, que ce soit sur les cartes officielles de l'exposition (tirage 2514) et/ou sur la carte aéropostale Paris-Bruxelles et/ou sur un aérogramme.

Forgery

Hammer Price

4.5 On-line Bidding

We offer internet services as a convenience to our clients. We will not be responsible for errors or failures to execute bids placed on the internet, including, without limitation, errors or failures caused by (i) a loss of internet connection by either party for whatever reason; (ii) a breakdown or problems with the online bidding software and/or (iii) a breakdown or problems with your internet connection, computer or system. Execution of on-line internet bids on www.spink.com and Spink Live is a free service undertaken subject to other commitments at the time of the auction and we do not accept liability for failing to execute an online internet bid or for errors or omissions in connection with this activity. Buyers who acquire lots on the-saleroom.com will have a fee of 3% on the hammer price added to their invoice for using this facility.

4.6 Telephone Bids

If you make arrangements with us not less than 24 hours before the sale, we shall use reasonable endeavours to contact you to enable you to participate in bidding by telephone, but in no circumstances will we be liable to either the Seller or you as a result of failure to do so.

4.7 Currency Converter

At some auctions, a currency converter will be operated, based on the one month forward rates of exchange quoted to us by Barclays Bank Plc or any other appropriate rate determined by us, at opening on the date of the auction. 4.11 The Auctioneer's Discretion

The auctioneer has the right at his absolute discretion to refuse any bid to advance the bidding in such manner as he may decide to withdraw or divide any Lot, to combine any two or more Lots and, in the case of error or dispute, to put an item up for bidding again.

4.12 Successful Bid

Subject to the auctioneer's discretion, the striking of his hammer marks the acceptance of the highest bid, provided always that such bid is higher than the Reserve (where applicable), and the conclusion of a contract for sale between you and the Seller.

4.13 After Sale Arrangements

4.14 Return of Lot

We may then request that the Lot is returned to us for inspection. Save as set out in clause 5.13, the cancellation of the sale of any Lot and the refund of the corresponding purchase price is entirely at our sole discretion. We will not normally exercise that discretion if the Lot is not received by us in the same condition that it was in at the auction date.
- 4.14.2 No lot may be returned on account of condition if the condition was stated by a third party grading company (including, but not limited to PCGS, NGC, ANACS, ICG, PMG, WBG).

5 AFTER THE AUCTION

5.1 Buyer's Premium and other charges

In addition to the Hammer Price, you must pay us the Buyer's Premium at a rate of 20% of the final Hammer price of each lot, a fee of 3% on the hammer price total for using the-saleroom.com and a fee for paying by card.

5.2 Value Added Tax

Other than in respect of Zero-rated Lots (o) VAT is chargeable on the Hammer price and the Buyer's premium of daggered (†) and (Ω) lots at the standard rate (currently 20%), and on lots marked (x) at the reduced rate (currently 5% on the Hammer price and 20% on the Buyer's premium). 5.3 VAT Refunds

General

VAT Refunds - Buyers from within the EU

- 5.3.4 VAT refunds are available on the Hammer Price and Buyer's Premium of Daggered (†) and Investment Gold (g) Lots. You must certify that you are registered for VAT in another EU country and that the Lot is to be removed from the United Kingdom within 3 months of the date of sale.
- 5.3.5 Where an EU buyer purchases a Lot on which import VAT has been charged, no refund of VAT is available from us. It may be possible to apply directly for a refund on form VAT 65 to HM Revenue & Customs Overeseas Repayment Section, Londonderry.

VAT Refunds - Buyers from outside the EU

- 5.3.6 Where a Lot is included within the Auctioneers' Margin Scheme and evidence of export from the EU is produced within 3 months of the date of sale, the VAT on Buyer's Premium may be refunded.
- 5.3.7 Where the Lot is marked as a Daggered (†) Lot the VAT charged on the Hammer Price may be refunded where evidence of export from the EU is produced within 3 months of the date of sale. A refund of VAT charged on the Buyer's Premium can also be made on receipt of proof of business as a collectibles dealer.
- 5.3.8 Where the Lot is marked as an Omega (Ω) Lot or an Import VAT (x) Lot and evidence of export from the EU is produced within 3 months of the date of sale, the VAT charged on both the Hammer Price and Buyer's Premium may be refunded. Where required, we can advise you on how to export such Lots as a specific form of export evidence is required. Where we advise you on the export of the Lots, please be aware that the ultimate responsibility in respect of obtaining a valid proof of export certificate will lie with you and we will not be responsible for your failure to obtain such certificate.
- 5.3.9 Lot marked as Investment Gold (g) is exempt from VAT on Hammer price. A refund of VAT charged on the Buyer's Premium can be made on receipt of proof of business as a collectibles dealer and where evidence of export from the EU is produced within 3 months of the date of sale.

5.4 Payment

- 5.4.1 You must provide us with your full name and permanent address and, if so requested, details of the bank from which any payments to us will be made. You must pay the full amount due (comprising the Hammer Price, the Buyer's Premium and any applicable VAT) within seven days after the date of the sale. This applies even if you wish to export the Lot and an export licence is (or may be) required.

Collection of Purchases

- Remedies for non-payment or failure to collect purchases 5.10.1 If you fail to make payment within seven days of your stipulated payment date set out in your invoice, we shall be entitled to exercise

- 5.10.2 If you fail to make payment within thirty-five days, we shall in addition be entitled:
 - 5.10.2.1 to cancel the sale of the Lot or any other item sold to you at the same or any other auction;

 5.10.3 If you fail to collect within fourteen days after the sale, whether or not payment has been made, you will be required

- 5.12.3 You should always check whether an export licence is required before exporting. Export licences are usually obtained within two or three weeks but delays can occur.
- 5.12.4 Unless otherwise agreed by us in writing, the fact that you wish to apply for an export licence does not affect your obligation to make payment within seven days nor our right to charge interest on late payment.
- 5.12.5 If you request that we apply for an export licence on your behalf, we shall be entitled to recover from you our disbursements and out of pocket expenses in relation to such application, together with any relevant VAT.
- 5.12.6 We will not be obliged to rescind a sale nor to refund any interest or other expenses incurred by you where payment is made by you despite the fact that an export licence is required.

5.13 Refund in the case of Forgery

- 5.13.1 A sale will be cancelled, and the amount paid refunded to you if a Lot (other than a miscellaneous item not described in the catalogue) sold by us proves to have been a Forgery.  - 5.13.1.4 you must provide to us all evidence obtained by you that a Lot is a Forgery no later than 7 days after you receive such evidence.
- 5.13.2 In no circumstances shall we be required to pay you any more than the amount paid by you for the Lot concerned and you shall have no claim for interest
- 5.13.3 The benefit of this guarantee is not capable of being transferred, and is solely for the benefit of the person to whom the original invoice was made out by us in respect of the Lot when sold and who, since the sale, has remained the owner of the Lot without disposing of any interest in it to any third party.
- 5.13.4 We shall be entitled to rely on any scientific or other process to establish that the Lot is not a Forgery, whether or not such process was used or in use at the date of the auction.

LIABILITY

Nothing in these Terms and Conditions limits or excludes our liability for:

death or personal injury resulting from negligence; or

any damage or liability incurred by you as a result of our fraud or fraudulent misrepresentation.
